### **Responsibilities of the Student Include;**

1. Student is responsible for obtaining *all knowledge on State and local regulations regarding permanent cosmetics* and being held responsible for deciding whether the training they are intending to take part in, is in conflict with any regulatory requirements.
2. A non-refundable deposit (50%) will be included with the enrollment form in order to insure the student's placement in the course. Once the required deposit has been made, training materials will be presented in person or mailed as agreed upon.
3. If for any reason the student is unable to attend a session due to personal reasons and/or an emergency the class will be reschedule. Punctuality is also critical. Time lost for not arriving on time or leaving a session early will not be made-up.

4. If there are any allergies or special needs a student requires, they must be expressed immediately. Ex: latex allergy, non-latex gloves required, etc.
5. Student must agree to be available to work at occasions organized and agreed upon by both parties in writing through email.
7. Each student is responsible for their own transportation, housing, and storage of materials. PUREBEAU USA Academy is not responsible for lost or stolen materials.
8. Completing pre-class assignments and following directions exactly as instructed by instructors is required. Student must be sure to come to classes prepared with materials well studied.
